Free in-home energy reviews with a trained Clark Public Utilities Energy Counselor are available for customers who want to learn how to reduce waste and save on utility expenses. This popular service is designed to help customers identify and prioritize cost-effective ways to make their homes more comfortable and energy efficient, or to investigate unexpected changes in energy use when there haven't been significant changes to the customer's lifestyle or living conditions.

Home energy reviews are perfect for customers with older homes where small changes could make a big difference in lowering energy costs, or for those considering remodels, home system upgrades or significant investments like a furnace or windows. Energy Counselors can help with low- or no-cost ways to prevent wasted energy, and can also help prioritize bigger projects that may qualify for current energy efficiency rebates or incentives.

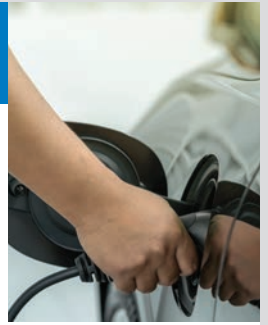

## STATE, FEDERAL AND CLARK PUBLIC UTILITIES INCENTIVES AVAILABLE FOR EV BUYERS

You've seen them on the street! Electric vehicle adoption continues to grow in Clark County, with nearly 50 percent increases in EV ownership each year.

As a non-profit, at-cost energy provider, Clark Public Utilities is committed to providing a robust power grid to support the growing number of vehicles fueled by electricity, and is planning for the future.



The utility's Transportation Electrification Plan includes a range of incentives to benefit customers interested in EVs across incomes and industries, including generous instant rebates for residential Level 2 chargers through our online marketplace.

Washington State also offers tax exemptions on the purchase of select EVs and chargers. In August, the Department of Commerce plans to launch the EV Instant Rebate Program for residents with household incomes at 300 percent or below the federal poverty level. ## STATE CLEAN ENERGY CREDITS COMING FOR CLARK PUBLIC UTILITIES CUSTOMERS

Customers who've participated in a Clark Public Utilities energy assistance program or other state assistance program at any point since January 2022 may be pre-qualified and automatically enrolled to receive a one-time electric utility account credit of \$200 from the Washington Department of Commerce. Anyone can apply, but those who are highly likely to qualify may be contacted directly by text message from the state program contractor, Promise, and encouraged to apply for a credit through the state's online application portal.

Credits must be applied to eligible accounts before Sept. 15, 2024 and applications will remain open as long as funds are available. Learn more about the program and how to apply at [clarkpublicutilities.com/WFCEC](https://clarkpublicutilities.com/WFCEC).
